## Vaisala Photo Contest Official Rules ("Rules")

- **1. ELIGIBILITY:** The Vaisala Photo Contest is open only to all persons who have delivered a lightning photo as instructed below, are 18 years of age or older and are legal residents of the United States, or any of the European Union countries or countries wherein Vaisala has companies and /or offices. Employees, officers and directors of Vaisala and each of its related companies and agents, as well as the immediate family (defined as parents, spouse, children, siblings and grandparents) and household members of each such employee, officer and director are not eligible to enter. By participating in the Contest, entrant fully and unconditionally agrees to and accepts these Rules and the decisions of Vaisala, which are final and binding.
- **2. SPONSOR:** Vaisala Inc., (a Delaware corporation with offices located at 194 South Taylor Avenue, Louisville, Colorado 80027, USA.
- **3. CONTEST PERIOD:** The Contest begins April 25, 2012 and ends on July 1, 2012 midnight, Boulder, Colorado, USA time.
- **4. HOW TO ENTER:** There are two ways to enter the Contest: During the Contest Period, send only one (1) of your best unretouched and unedited lightning photo with your contact information to <a href="Melanie.Scott@vaisala.com">Melanie.Scott@vaisala.com</a>, or enter the contest through Vaisala's FaceBook Event page. Only one (1) entry per person.
- 4.1. FOR ALL ENTRIES: All entries must be received during the effective dates of the Contest Period, submittals after the contest end date will not be accepted. Any use of automatic, programmed or similar entry methods or agents (including but not limited to sweepstakes/contest entry services) will void all entries by that entrant. Proof of entry submission (if any) will not be deemed to be proof of receipt by Sponsor. All entrants must submit a valid email and postal address. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected entries, all of which will be disqualified. Retouched or edited photos are subject to disqualification by Sponsor. The photo must be delivered in JPG or GIF format and the entrant must own the copyright to the photo. Such copyright must be properly marked. In the event, the photo entry submitted contains identifiable persons other than the entrant, the entrant must provide the Sponsor written permission to use the photo from the respective persons. In the event of a dispute as to the identity of an entrant, the authorized account holder of the email address used to enter will be deemed the entrant. The "authorized account holder" is the natural person assigned to the email address by the organization responsible for assigning email addresses for the respective domain.
- **5. DRAWING AND NOTIFICATION OF POTENTIAL WINNERS:** The potential winner will be selected at random from among all eligible entries received. Selection will be held one (1) day after the closing of the Contest period. Sponsor, will conduct the drawing and will select the winner. The winner will be notified by electronic mail within seven (7) days of the drawing. Entrant further agrees that in any cause of action, will be limited to the cost of entering and participating in the Contest. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct or indirect damages. Except where prohibited, entrant agrees that any and all disputes, claims and causes of action arising out of or connected with this Contest or any prize awarded shall shall be governed by and construed in accordance with the laws of the State of Colorado, without regard to its conflicts of laws provisions, and all legal proceedings shall be subject to the exclusive jurisdiction of the federal and state courts in the State of Colorado.
