

### 1. Application

These General License Conditions ("License") shall apply to all quotations, confirmations and contracts for the licensing, use, delivery, service, updates, upgrades, maintenance or replacement of any software, including associated documentation and material ("Software"), by Vaisala Oyj or any Vaisala Group Company ("Vaisala" or "Licensor") to its customer ("Customer" or "Licensee").

This License constitutes a legally binding agreement between Vaisala and the Customer, and shall take precedence over any inconsistent or conflicting provision in any prior agreement, representation or understanding relating to the Software. BY ACCESSING, DOWNLOADING, INSTALLING OR USING THE SOFTWARE, THE CUSTOMER SHALL BE DEEMED TO HAVE ACCEPTED THIS LICENSE AND AGREE TO BE BOUND BY ITS TERMS. UNLESS A SEPARATE WRITTEN CONTRACT HAS BEEN SIGNED WITH THE CUSTOMER, THIS LICENSE SHALL SOLELY GOVERN THE LICENSING, USE, DELIVERY, SERVICE, UPDATES, UPGRADES MAINTENANCE AND REPLACEMENT OF THE SOFTWARE.

This License further applies to any and all updates or upgrades of the Software that Vaisala may supply, unless Vaisala provides other terms along with such update or upgrade.

To the extent any third party software or technology is delivered by Vaisala to be used in connection with the Software or if any third party component, including open source software, is included in the Software, this License shall incorporate with reference the terms and conditions concerning such third party software, including all restrictions and limitations on usage rights.

### 2. License; License Fee

Upon execution of the License and payment of the License Fee, if any, the Licensor grants to the Licensee a non-exclusive, nontransferable limited right to use one copy of the Software in the specified applications (the "Designated Applications"), serving the use of the equipment delivered to the Licensee by Licensor (the "Designated Equipment"), at the specified location, for Licensee's internal purposes during the term of this License. The limited use right allows the Licensee to: i) operate and control the Designated Equipment; ii) collect and display data from the Designated Equipment; iii) use the Designated Applications; and iv) make copies of the Software for back-up purposes to the extent mandatory applicable law so permits. These rights shall be limited to those sections, features and the like of the Software to which specific rights have been separately granted, in accordance with Licensee's payment obligation relating to the same.

Licensee shall not use the Software or let it be used for any other purpose than those explicitly stated herein. In particular, the Licensee is not permitted to use the Software in any other location or in any other systems than the Designated Applications and the Designated Equipment. Further, the Licensee may not and may not allow a third party to modify, translate, adapt, disclose, lease, rent, loan, redistribute, sublease, sublicense or create derivative works from the Software. In particular, the Licensee shall not reverse-engineer, decompile or disassemble the Software, except and only to the extent that mandatory applicable law notwithstanding this limitation expressly permits such activity. In such case the Licensee shall first request Licensor to provide the Licensee with the necessary information. Licensor has the right to impose reasonable conditions such as a reasonable fee providing the said information.

### 3. Disclaimers

THE SOFTWARE IS PROVIDED "AS IS", AND LICENSOR DISCLAIMS (ALSO ON BEHALF OF ITS LICENSOR'S) ANY AND ALL WARRANTIES AND CONDITIONS, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO, ANY WARRANTIES OF NONINFRINGEMENT, THE IMPLIED WARRANTIES AND CONDITIONS OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OF THE SOFTWARE. LICENSOR DOES NOT WARRANT THAT THE SOFTWARE IS FREE OF CLAIMS FOR INFRINGEMENT, THAT THE FUNCTIONS CONTAINED IN THE SOFTWARE WILL MEET LICENSEE'S REQUIREMENTS, OR THAT IT IS SUITABLE FOR ANY APPLICATION. FURTHER, LICENSOR DOES NOT WARRANT THAT THE OPERATION OF THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR-FREE, THAT IT IS FREE OF ANY OMISSION, INACCURACY, DEFECT, COMPUTER VIRUS, OR OTHER OPERATIONAL OR PERFORMANCE PROBLEM, OR THAT DEFECTS IN THE SOFTWARE WILL BE CORRECTED. LICENSEE WILL BE RESPONSIBLE FOR ADEQUATELY SAFEGUARDING (SUCH AS BY BACKING UP) ANY DATA AND OTHER SOFTWARE CONJUNCTION WITH THE SOFTWARE. USED IN NO LIABILITY LICENSOR ASSUMES FOR ANY CORRUPTION, ERASURE, MISHANDLING, OR THE LIKE OF LICENSEE'S DATA OR OTHER SOFTWARE. NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY LICENSOR OR ITS REPRESENTATIVE SHALL CREATE A WARRANTY OR IN ANY WAY LIMIT THE SCOPE OF THESE DISCLAIMERS. ADDITIONALLY, LICENSEE ACKNOWLEDGES RECEIVING NO WARRANTY, EXPRESS OR IMPLIED, FROM ANY THIRD PARTY, INCLUDING POSSIBLE LICENSORS OF THE LICENSOR, REGARDING THE SOFTWARE, ANY THIRD PARTY SOFTWARE OR THIS LICENSE.

### 4. Limitation of Liability

THE DISCLAIMER OF WARRANTIES RECITED ABOVE IS FOR THE PURPOSE OF LIMITING LICENSOR'S LIABILITY FOR ANY DAMAGE OR HARM SUFFERED BY LICENSEE OR A THIRD PARTY, WHETHER FOR BREACH OF CONTRACT, AN ACTION IN TORT (INCLUDING STRICT LIABILITY), NEGLIGENCE, INFRINGEMENT, OR UNDER ANY OTHER CAUSE OF ACTION OR CAUSED BY ANY THIRD PARTY OF ASSOCIATED SOFTWARE AND/OR SUPPLIERS SOFTWARE COMPONENTS INCLUDED IN THE SOFTWARE. LICENSOR SHALL NOT BE HELD LIABLE FOR ANY SUCH CLAIMS OR ACTIONS, AND THE RISK OF HARM FROM THE FOREGOING RESTS ENTIRELY WITH LICENSOR LICENSEE. AND ITS SUBSIDIARIES, AFFILIATES, OFFICERS, EMPLOYEES, AGENTS AND LICENSORS SHALL NOT BE LIABLE TO THE CUSTOMER FOR ANY DIRECT, INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES,



INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR LOSS OF PROFIT, REVENUE, GOODWILL, BUSINESS, PRODUCTION, DATA OR OTHER INTANGIBLE LOSSES, INCREASED COST OF PRODUCTION OR OPERATION, OR LIABILITIES OF THE CUSTOMER TO ANY THIRD PARTY, RESULTING FROM OR RELATING TO THE USE OF OR INABILITY TO USE THE SOFTWARE EVEN IF LICENSOR HAS BEEN INFORMED OF THE POSSIBILITY OF SUCH LOSSES.

IN NO EVENT SHALL LICENSOR'S LIABILITY TO LICENSEE FOR ANY CLAIM OF DAMAGES, LOSSES AND CAUSES OF ACTIONS WHETHER IN CONTRACT, TORT (INCLUDING NEGLIGENCE), INFRINGEMENT, OR UNDER ANY OTHER LEGAL THEORY (INCLUDING STRICT LIABILITY) EXCEED THE TOTAL AMOUNT OF LICENSE FEES.

LICENSEE ACKNOWLEDGES THAT THE FOREGOING CONSTITUTES LICENSEE'S SOLE AND EXCLUSIVE REMEDY FOR BREACH BY LICENSOR OF THIS LICENSE OR ANY WARRANTIES MADE HEREUNDER AND FOR ALL CLAIMS AND DAMAGES BY LICENSEE OR ANY THIRD PARTY.

### 5. Intellectual Property Rights

Licensor represents and Licensee agrees that the Software, including source and object code and associated documentation and material, is confidential and proprietary to Licensor and/or its licensors. All confidentiality and proprietary notices, including but not limited to copyright notices displayed on the Software, shall remain intact and unaltered and shall be included on any documents, media, printouts, visualizations, or on any other electronic or tangible expressions associated with, related to, or derived from the Software.

Licensee acknowledges that Licensor and/or its licensors has full right, title, and interest in and to all associated, related, and resultant intellectual property, which includes but is not limited to patents, trade secrets, trademarks, and copyrights, including any and all derivative works thereof, to the Software.

To the extent any third party software or technology is accessed or used in combination with the Software, Licensee shall be obligated to obtain all necessary usage rights (including applicable restrictions and limitations) to such third party software or technology, unless the same has been delivered to Licensee by Licensor. Licensee assumes the entire responsibility and liability therefore, including any associated costs and expenses.

# 6. Export Law Assurances

Licensee agrees to comply with all applicable export laws, restrictions and regulations, including those of the jurisdiction in which the Software was obtained or will be used.

# 7. Invoicing and Payment

Initial License fee shall be payable against Licensor's invoice within thirty (30) days from the execution of this License.

Subsequent License fees shall be invoiced on a monthly basis (payment term thirty (30) days net), unless otherwise agreed.

Any payment outstanding after the due date shall accrue interest at the rate of twelve per cent (12 %) per annum on the unpaid amount from the date such payment becomes due.

### 8. Indemnity

If Licensor incurs liability towards any third party for loss or damage arising out of or in connection with this License or the Software, the Licensee shall indemnify, defend and hold Licensor harmless.

### 9. Audit

Licensor has the right to audit Licensee's use of the Software by providing at least seven (7) days prior written notice of its intention to conduct such an audit. The audit right shall not terminate or expire until three (3) years after termination or expiration of this License.

### 10. Force Majeure

Licensor shall not be liable for delay in delivery, completion of work or service or other failure to duly fulfil its obligations, if the delay or failure results from a strike or other industrial or labour dispute, fire, flood, natural catastrophe, riot, war, general mobilization, import, export or currency restriction or embargo, circumstance caused by reasons of law, regulations or acts (or failures to act) of any governmental or other authority, traffic, port or airport congestion, delay or accident during transportation, power failure, failure of telecommunications, acts of terror, widespread life-threatening disease, shortage of labour, materials, power, fuel or means of transportation or other similar events, whether affecting Licensor or any of its suppliers, licensors or subcontractors, or unavailability, incompleteness or inaccuracy of any technical or other information which is the responsibility of the Licensee to provide, or any other cause or circumstance beyond Licensor's reasonable control.

### 11. Term and Termination

This License enters into force upon the execution of the License and the payment of the License fee, if any, and shall remain in force for an indefinite period of time, subject to the Licensee possessing the Designated Equipment and the payment of all License fees. When this License has been granted for the purpose of evaluating the Software or for similar trial activity only, this License shall terminate automatically after the evaluation period.

In the event that the Licensee no longer possesses the Designated Equipment, this License shall terminate automatically. Further, this License may be terminated with immediate effect by Licensor by written notice if the Licensee fails to comply with this License.

Upon any termination, the Licensee shall immediately cease to use the Software and promptly return to Licensor all copies of and materials concerning or incorporating the Software.



### 12. Arbitration and Law Applicable

This License shall be construed, governed and interpreted in accordance with the laws of Finland, excluding its conflict of laws rules thereof. It is expressly agreed that the application of United Nations Convention on Contracts for the International Sale of Goods (CISG) shall be excluded.

Any dispute, controversy or claim arising out of or relating to this License, or the breach, termination or validity thereof, shall be finally settled by arbitration in accordance with the Arbitration Rules of the Finnish Central Chamber of Commerce. The Arbitral Tribunal shall consist of one (1) arbitrator. The arbitrator shall be appointed in accordance with the Arbitration Rules of the Finnish Central Chamber of Commerce. The award shall be final and enforceable in any court of competent jurisdiction. The arbitration shall be held in Helsinki, Finland, and be conducted in English.
